

# PRIVACY POLICY

This website is operated by InfinOty Ltd whose registered address is The Bothy, Chilworth Manor, Halfpenny Lane, Chilworth, Surrey, UK GU4 8NN (“We”). We are committed to protecting and preserving the privacy of our visitors when visiting our site or communicating electronically with us.

This policy sets out how we process any personal data we collect from you or that you provide to us through our website. We confirm that we will keep your information secure and that we will comply fully with all applicable UK Data Protection legislation and regulations. Please read the following carefully to understand what happens to personal data that you choose to provide to us, or that we collect from you when you visit this site. ## 1. Types of information we may collect from you

We may collect, store and use the following kinds of personal information about individuals who visit and use our website:

### **Information you supply to us.**

You may supply us with information about you by filling in forms or by purchasing or attempting to purchase products on our website. **Technical information**, including a truncated and anonymised version of your Internet protocol (IP) address, browser type and version, operating system and platform.

**Information about your visit**, including what pages you visit, how long you are on the site, how you got to the site (including date and time); page response times, length of visit, what you click on, documents downloaded and download errors.

**Cookies**, our website uses cookies to distinguish you from other users of our website. This helps us to provide you with a good experience when you browse our website and also allows us to improve our site. ## **2. How we may use the information we collect**

We use the information in the following ways:

### **Information you supply to us**

We will use this information:

generally, to fulfil any orders placed through the Site (including processing your payment information, arranging for delivery and providing you with invoices and/or order confirmations).

Additionally, we use this Information to:

Communicate with you; screen our orders for potential risk or fraud; and when in line with the preferences you have shared with us, provide you with information or advertising relating to our products or services.

### **Information we automatically collect about you**

We will use this information:

to administer our site including troubleshooting and statistical purposes;

to improve our site to ensure that content is presented in the most effective manner for you and for your computer;

security and debugging as part of our efforts to keep our site safe and secure.

This information is collected anonymously and is not linked to information that identifies you as an individual.

## **3. Disclosure of your information**

### **Storage and Sharing**

Any information you provide to us will either be emailed directly to us or may be stored on a secure server. We use a trusted third-party website and hosting provider (Domains) to facilitate the running and management of this website. Domains meets high data protection and security standards and are bound by contract to keep any information they process on our behalf confidential. Any data that may be collected through this website that Domains processes, is kept secure and only processed in the manner we instruct them to. Domains cannot access, provide, rectify or delete any data that they store on our behalf without permission.

We do not rent, sell or share personal information about you with other people or non-affiliated companies

We will use all reasonable efforts to ensure that your personal data is not disclosed to regional/national institutions and authorities, unless required by law or other regulations.

Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to our site; any transmission is at your own risk. Once

we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.
